Dear Sir :

I am **Fariborz Roshanfekar**, an Iranian scriptwriter. An obvious right of mine has been violated by the American company of Walt Disney. Since I can't sue to the American courts, I have to lodge my complaint in this manner.

In 1999, before Cinderella 2 and 3 were made, I sent Walt Disney a general plot, which is attached to this letter now. Walt Disney confirms in written that they received my general plot in 1999, but refrain from accepting plagiarize.

My claim is that the script of Cinderella 3 has totally written based on my general plot. In the letter I wrote in objection to this illegal action to Mr. Robert A. Iger, the President and Chief Executive Officer of the Walt Disney, but instead of mooting my claim at the board of specialists, he placed a nonexpert person to answer me.

My request is to employ at least three neuter script experts to compare my general plot with the script of Cinderella3 and give you their professional opinion about it to let you judge fairly.

Points in common between my general plot and Cinderella3:

* **The entrance of evil in to the Cinderella's story** (in Cinderella 3 when the stepmother gets hold of the Fairy Godmother's magic wand, and wants help from evil powers and from then on the light of the magic want turns into green. It is infact the indirect entrance of evil into the story.)

Dear Mr. Rowshanfekr:

Your letter dated April 1, 2009, addressed to Robert A. Iger but sent to about two dozen others, has been referred to me for response.

I have re-reviewed your enclosures and must conclude that there is no way to accept or agree with your assertions. First, what I wrote you in my letter of November 10, 1999, was correct then and is correct now. Second, there is no connection, nor could there be, between your letter of October 10, 1999, and the development of the motion picture "Cinderella III." Third, there is no similarity between what you describe in that letter and the story of "Cinderella III" and your vague reference to the device of "the past" does not support your contention of "illegal copying."

Unlike how your letter was handled in 1999, this time I will retain a copy of what you have sent, as you seem to be making an accusation of wrongdoing, which the Company hereby denies.
